SAML/SSO – New Feature Available for Gold Customers

Show Prior KBS Ratings in Charting

When a client has charting, and a problem has Knowledge Behavior Status (KBS) being tracked from visit to visit, you will now see the ratings from the most recent visit that have any or all of KBS recorded. This will be in the **Problem Details**, under **Signs & Symptoms**, in a gray box.

Add Detail Level > Activity Program and Activity Cost Center To Reports

When creating a report using the **Ledger detail info** report screen, you can now report on and filter by **Activity cost center** and **Activity program**. This allows for the breakdown and filtering of activities that have been billed and contain data in the **Program** and/or **Cost center** fields in the activity.

Show Score Questions for All Assessment Forms in Reports

The **Score** field will now be available for any assessment forms that have scores and that are in the **Reports** screen.

New Behavior in “New Related Activity”

If you add a **New related activity** from an FHV activity, and you go immediately to the **Charting** tab or elsewhere without saving, when you go back to **Activity Details**, the information you had

previously entered will not have been saved. There previously was no warning that this would happen.

Now, if you attempt to navigate away from **Activity Details**, such as to go to **Charting, Vitals**, etc., you'll get a warning that states you will lose your changes.

Also, in addition to the **Save** button in the **New related activity** popup box, there is a **Save and Close** button. If you click **Save**, it will save your data and not leave the activity. **Save and Close** will take you out of the activity.

Change of Type of Selection for "Add Existing Screening"

When in IHVE and you click on **Add existing screening**, there were radio buttons for the assessments, which means that you could only choose one. Now the assessments have checkboxes next to them and you can select multiple assessments at one time.

KBS Change Graphs Report Can Now Be Filtered By Program

The KBS Change Graph Report, that you can find under the Agency Administration Reports, now has the ability for you to filter by Program along with all of the other filters.

Health History Birth Weight Now Has Decimal for Ounces

Under the Health History tab, you can add values to a section called Birth History. One of those fields is Birth Weight. It came to our attention that you were not able to add a decimal place. You will not have that ability.

Minnesota/IHVE Users Only – Interpreter Question Will Autofill

If you have completed the initial FHV enrollment visit for a family and submitted to MDH, the visit form will pre-populate with the previous response for the interpreter question on the Visit form for all subsequent visits.

OASIS-E Now Added – Use for OASIS Starting January 1st, 2023

The long-anticipated OASIS-E is now in Nightingale Notes. It includes several new items, some in new tabs.

- New Tabs in OASIS – or Change to Names of Tabs
 - Administrative Information (Formerly Home Health Patient Tracking)
 - Hearing, Speech and Vision
 - Cognitive Patterns
 - Mood
 - Behavior
 - Preferences for Customary Routine Activities
 - Functional Status
 - Bladder and Bowel
 - Health Conditions
 - Swallowing/Nutritional Status
 - Skin Conditions
 - Special Treatments, Procedures and Programs
 - Participation in Assessment and Goal Setting

You will be able to tell which are new items, because they are preceded with letters other than “M.”

Some new items have a score, after answering them, for example C0200-400 is a Brief Interview for Mental Status (BIMS). The score does not show in the OASIS but will be recorded and sent in the OASIS file that goes to iQIES.

Other than the changes noted, everything else in the OASIS works the same as before.
